H. D. Thomas appeared and asked that he be permitted to withdraw has sever petition which has been on file pending action since September 12, 1945. Since the City Engineer refuses to approve a sever as requested by Mr. Thomas, the board granted Mr. Thomas's request and returned the petition.

The following rules and regulations were adopted governing the sanitary conditions at Lone Star Lake.

SANITATION RECULATIONS FOR LONE STAR LAKE

To maintain the camping facilities at this Lake in a safe sanitary condition, the following regulations are to be followed by all parties who use any of the camp area:

TRASH DISPOSAL is the responsibility of the camper.

- 1. All burnable trash must be burned in approved metal trash burners, and close supervision maintained by the camper until burned out.
- 2. All non-burnable trash must be deposited in pits and covered with a layer of dirt daily. Tin cans should be flattened before disposal.
- 3. All pits must be filled in when trash has reached within two (2) feet of the surface and marked with a stick giving date of closure.

CARBAGE DISPOSAL

All garbage must be placed in metal containers with a tight fitting lid and kept covered at all times.

The garbage containers are to be kept outside of the buildings and will be emptied by the caretaker or his assistant daily.

LATRINES

All Latrines are to be kept in a sanitary condition at all times, and lids to seats must be kept down when not in use; and dcors are to be kept closed.

SWIMMING

Swimming shall be limited to prescribed beach area, and will be limited to not more than 20 persons at one time, and there shall be a minimum of one (1) life guard on duty at such times, furnished by the group and registered with caretaker.

No further business the board adjourned to meet July 11th to hear the bindweed budget and to meet with T. F. Yost, of the State Bindweed Repartment.
