The Board of County Commissioners met in regular adjourned session, all members of board being present. The abstracting bond of V. P. Wilson was approved by the board, which bond is for the term of five years and in the amount of \$7,500.00. Roy Flory, County Treasurer, appeared before the board with a list of several pieces of property which appear on the tax roll in North Lawrence. All of the lots have been in the river for several years and are just sold and resold at the Judicial Tax Sales. After discussing the removal of the lots from the tax roll, the County Attorney was instructed to see if there was any possible way to remove these lots from the tax rolls completely.
