November 1, 1946.

The Board of County Commissioners of Douglas County met in regular adjourned session, Commissioners L. H. Griffith and Ed Johnson being present.

The regular monthly bills for payroll and services were approved and allowed as per the allowance record.

A petition was presented to the Board by Herbert H. Harris, of Tonganoxie, Kansas, and Bessie G. Harris, his wife, dated October 28, 1946, requesting that a sewer be laid across 19th Street and connected to the City sewer. The City Engineer, Frosty Harper, was consulted, and it was decided to not act on the petition but to leave it open for further discussion.

The following Resolution and Certificate was received by the Board from John J. Riling, Attorney, representing the Mayor and Councilmen of the City of Eudora, in regard to the petition of Carl Perkins and others, praying for the vacating of that portion of Eudora City north of the Wakarusa River:
