RESOLUTION

WHEREAS a petition has been filed in the County Clerk's Office of Douglas County, Kansas, and directed to the Board of County Commissioners of said county, praying for the vacation and exclusion from the city limits of Eudora, Douglas County, Kansas, the following described property, to-wit:

All blocks, lots, streets, alleys and other land which lies within the City of Eudora, and is located south of the Kansas River and north of Wakarusa River and West from where said two rivers join, the west line of said tract being the west line of the city limits of Eudora, Douglas County, Kansas.

Said property being otherwise described as blocks 66 to 70 inclusive, blocks 100 to 105 inclusive, blocks 138 to 141 inclusive, blocks 174 to 176 inclusive, blocks 210 to 211; Streets E. to I inclusive and First Street to Fourth Street inclusive.

and WHEREAS notice of the hearing on said petition has been published as provided for in Section 12-504 of the General Statutes of Kansas, 1935, and

WHEREAS, according to the laws of the State of Kansas, in order for said petition to be granted, the recommendation of the governing body of the city wherein said land is located, and which is to be vacated, must be obtained

NOW THEREFORE be it resolved by the Mayor and Council of the City of Eudora, Douglas County, Kansas, that the petition of Carl C. Perkins, P. J. Neis and John Schopper, above referred to, be granted, and the real estate hereinbefore described be vacated and excluded from the boundaries of the City of Eudora, Douglas County, Kansas, and said governing body not only recommends but requests that said petition be granted.
