The Board of County Commissioners of Douglas County met according to law to canvass the votes of the General Election held on Tuesday, Novamber 5, 1946. No changes in the results were made.

Additional bills for services and supplies were approved and allowed as per the Allowance Record.

Cancellation Order No. 433 was approved and issued.

An agreement between the governing body of the City of Lawrence and the Douglas County Commissioners, establishing Sewer District No. 6, was presented to the Board for their approval, and to obtain the signature of L. H. Griffith as Chairman of the Board, and T. R. Gerhart as County Clerk, then returned to City Engineer Frosty Harper.

AGREEMENT

THIS AGREEMENT made and entered into this 28th day of October, 1946, by and between The Board of County Commissioners of Douglas County, Kansas, and the Governing Eody of the City of Lawrence, Kansas, a city of the first class, WITNESSETH, that:

Whereas, under the provisions of Chapter 165 of the laws of The State of Kansas of 1927, the Board of Commissioners of Douglas County, Kansas, is forming what is known or to be known as the Douglas County Sewer District No. 6, the same to comprise the following described tract of land, to wit:

> The Southeast quarter of the Northeast quarter of the Southeast quarter of Section 1, Township 13, Range 13, Douglas County, Kansas, and

Mnereas, it is the desire of said Board of County Commissioners to connect said Douglas County Sewer District No. 6 to the sanitary sewer system of the City of Lawrence, Kansas, as follows:

> Beginning at a manhole to be built in the City sanitary sewer located at the Northeast corner of Lot 27, Learnard's subdivision (formerly the center of Park Place, now vacated), thence West 342 feet to a manhole.

and the Governing Body of said City is willing that such connection be made and that the sewage from said sewer district may flow through the main of the sewer system of the City on certain terms and conditions.

It is therefore agreed by the said parties as follows:

1. In consideration of the sum of One Dollar (\$1.00) to be paid by the Board of County Commissioners of Douglas County to the Governing Body of the City of Lawrence, Kansas, and the further covenants and promises herein contained, the Governing Body of the City of Lawrence, Kansas, does hereby grant to the Board of County Commissioners of Douglas County, Kansas, the right to connect the sewer system of said Douglas County Sewer District No. 6 to the sanitary sewer system of the City of Lawrence, Kansas, at the manhole to be tuilt in the City sanitary sewer system at the Northeast corner of Lot 27, Learnard's subdivision.

2. As a part of the consideration for the above said Board of County Commissioners does hereby agree that at such time as in the opinion of the Coverning Body of the City of Lawrence it is necessary to build or rebuild main sewers in said City, which main sewers under the present law are paid for by the city at large, that at such time the Board of County Commissioners, in behalf of said Douglas County Sewer District No. 6, will pay to the Coverning Body of the City of Lawrence such part of the cost of such new main sewers as the value of the real estate in Douglas County Sewer District No. 6 shall at the time bear to the value of the real estate within the corporate limits of the City of Lawrence, subject to tax for the construction of such sewer, plus the value of the real estate in said sewer system.

3. As one of the conditions to the above right, the said Board of County Commissioners does hereby agree that nothing shall be permitted to enter the sewer system of the City of Lawrence from the said Douglas County Sewer District No. 6 except such matter or material as is proper under the present ordinances of said city and such amendments as may be made thereto hereafter.

4. The said Board of County Commissioners does further agree that no residence shall be connected with the sever system in said Douglas County Sever District No. 6 until the plumbing thereof shall have been inspected and approved by the authorities of the City of Lawrence, and no house hereafter built therein shall be allowed to connect with said sever system until and unless the plumbing thereof shall have been installed in all respects in conformity with the ordinances of said city relating to plumbing, and until the owner of such residence shall have paid to said City of Lawrence the sum of Fifty Dollars (\$50.00) and shall have agreed to all of the conditions of this contract, including the granting of the right to the officials of the City of Lawrence to go upon his property at any time to inspect the sewer thereof and to disconnect the same so as to prevent it from emptying
