## 648.0 feet to the point of beginning in Douglas County, Kansas;

and that said description expressly states and shows that the said South Ridge Addition as being on and a part of Section Six (6), Township Thirteen South (13S), Range Nineteen East (19E) in Douglas County, Kansas, and that said description is erroneous for the reason that said South Ridge Addition was intended to be in and a part of Section One (1), Township Thirteen South (13S), Range Nineteen East (19E) in Douglas County, Kansas.

WHEREAS, the Board of County Commissioners of Douglas County, Kansas, further finds that Douglas County has more than 1200 inhabitants and less than 45,000 inhabitants and that said roads, streets, avenues and boulevards as described above are not a public utility by reason of nonuse, and said roads, streets, avenues and boulevards have become practically impassable, and the necessity for said roads, streets, avenues and boulevards as a public utility does not justify the expenditure of the necessary funds to lay out and repair said roads and put the same in condition for public travel.

WHEREAS, the Board of County Commissioners of Douglas County, Kansas, further finds that the said roads, streets, avenues, and boulevards as mentioned above are less than two (2) miles of consecutive roads, streets, avenues and boulevards, and that the Board of County Commissioners of Douglas County, Kansas, hereby vacates said roads, streets, avenues and boulevards in compliance with Section 68-102 of the Revised Statutes of Kansas, 1945.

NOW THEREFORE BE IT RESOLVED, by the Board of County Commissioners of Douglas County, Kansas, in regular session assembled this 16th day of November, 1946, and that the roads, streets, avenues and boulevards known as

McNeil Avenue, Hosford Avenue, Mcquary Avenue and Sutton Boulevard

being a part of the roads, streets, avenues and boulevards of South Ridge Addition, an addition to the Gity of Lawrence in Douglas County, Kansas; said addition being shown by plat and said plat is recorded in Plat Book 3 at page 19 in the Register of Deeds Office in Lawrence, Kansas, be vacated and excluded from the roads, streets, avenues and boulevards of Douglas County, Kansas, and that this resolution and order shall be entered at length upon the records of the proceedings of this Board of County Commissioners of Douglas County, Kansas; and that the County Clerk of Douglas County, Kansas, shall certify a copy of this resolution and order to the Register of Deeds of Douglas County, Kansas, which order the Register of Deeds shall record in the deed records of said County and shall write on the margin of the recorded plat of South Ridge Addition, the same being recorded in Plat Book 3 at page 19, the following notation:

> "EcNeil Avenue, Hosford Avenue, McGuary Avenue and Sutton Boulevard are hereby vacated by order of the Board of County Commissioners of Douglas County, Kansas".

giving reference thereof to the page and book of record where this order is recorded in said Register of Deeds Office.
