WHEREAS, the Board does find that the said Lawrence Country Club is in all ways qualified under the law to sell cereal malt beverages for consumption on the premises, and

WHEREAS, the Board further finds that due and legal notice has been given to the Wakarusa Township Board and that ten days have expired from the giving of said notice, and that no written objection has been filed by the Wakarusa Township Board, protesting the granting of a beer license.

NOW, THEREFORE, BE IT RESOLVED that the applicant, The Lawrence Country Club by George T. Wetzel, Secretary-Treasurer, be granted a license to sell cereal malt beverages for consumption on premises at the place so described in application.

The Board authorized Sheriff Johns to purchase thirty suits of unionalls from the Lawrence Army Surplus Co. at \$1.50 each, P. O. #648.

The bid of Anderson Brothers for sanding the residence part of the jail (8 rooms & hall) at \$202.44 was accepted. Ramseys bid of \$977.57 for painting, papering, and linoleums, for jail was accepted, P. O. #649.

The Board authorized the purchase and installation of a boiler unit from Olson Bros, to be installed at the jail, and at a cost not to exceed \$225.00.

The Board accepted the bid of Fred Bliesner from the Lawrence Type writer Exchange for two office stools for the Register of Deeds Office, the bid was for \$10.50 for both stools.

The Board authorized all officers of County to pay sixty cents (60¢) per hour for extra clerk hire, beginning January 1, 1947.

The wages of Harold Wilburn, janitor, were raised to \$150.00 per month.

The Board accepted the bid of Basil Green of \$274.50 for work on the County Treasurers counter.

The Board authorized the purchase of a gas turner, plus installations, at a cost of \$325.00 from Kansas Public Service Company, to be installed in the jail, in the present furnace.

No further business, the Board adjourned to meet January 2, 1947.
