March 10, 1947.

The Board of County Commissioners of Douglas County met in regular adjourned session, all members being present.

H. T. Melton and Carl Graeber appeared before the Board to discuss the assessment of city property.

Mr. Wells and Mr. Harold G. Garner appeared before the Board representing the Portland Cement Co. to discuss the merit of soil stabilized roads, and March 24 set as a date for a further meeting.

A representative of the Power Clock Service Co. appeared before the Board to report the Power Clock was worn badly and should be repaired. He also recommended the clock be converted to an electric service, and promised the Board literature on electric service would be sent them.

The license for Mr. Everett Cobb to sell beer was definitely denied.

The Clerk of the District Court, Mrs. Simmons, appeared before the Board, and was authorized to pay up to \$145.00 per month for a deputy, beginning March 1, 1947.

The Board met with the Welfare Department to discuss Welfare matters.

No further business, the Board adjourned to meet Wednesday, March 12.

The Board of County Commissioners of Douglas County met in regular adjourned session, all members being present.

Additional bills for equipment and supplies were approved and allowed as per the Allowance Record.

Commissioners Orders Nos. 474 and 475 were approved and ordered cancelled, and new tax adjustments made.

County Attorney Robert Oyler presented a transcript for Temporary Notes for Sewer #4 and Sewer #5 to be signed by the Commissioners.

On request of County Engineer E. E. Larson, the money collected for the Monarch tractor sold to Albert Otto, \$500.00, by motion of the Board was ordered to be deposited in the Road & Bridge Fund.

Ragan Exterminators presented a revised contract to exterminate the jail of ants. A lease for one year was signed by the Board, to be paid for by the month, and to terminate at any time on thirty days notice.

Everett Holley appeared in reference to a beer license for the Golden Arrow, and was informed that his application was rejected.

By proper motion and vote by the Board it was moved that the construction of bridges be postponed indefinitely until material could be obtained cheaper.

T. R. Gerhart, County Clerk, requested a raise of \$5.00 per month for Miss Cleland. The request was granted. It was also decided to raise the wages of Mrs. Eudaly and Mrs. Davis, in the County Treasurers Office, by \$5.00 per month, all three wages effective as of March 1, 1947.

It was resolved by the Board that no more salaries be raised at this time.

An order was given the Newlin-Mosbacher Co., by the Board, for 1 3/4 yard power shovel, less the dray line, at a cost of \$13,725.00 f.o.b. Milwaukee.

No further business, the Board adjourned to meet Saturday, March 15.
