The petition, signed by T. F. Connole and seventeen others, was presented to the Board the Board. praying for the location of a road in said county described as follows: "Beginning at a point $\frac{1}{2}$ mile South of the N. W. corner of Section #1, Township #13S, Range #17E; thence East $1\frac{1}{2}$ miles to intersect with the present County Road $1\frac{1}{2}$ miles South of Stull, all in Kanwaka Township." The Board met at 2:00 o'clock on March 17, 1947 at the place of beginning, and acting as a Board of Viewers, and accompanied by the County Surveyor, proceeded to view and give all persons a hearing. A representative of Newlin-Mossbacher called to discuss the purchase of a shovel by the County priced at \$11,349.00 f.o.b. Milwaukec. A representative for the NorthWestern Company appeared in behalf of Funkhouser Machinery Company, and priced a 3/4 yard NorthWestern shovel priced at \$11,779.87 f.o.b. Green Bay, Wisconsin. The Board moved and seconded that the County Attorney, Bob Oyler, be instructed to draw up a resolution showing the application of the County's share of the cost of Louisiana Street paving project, out of the Special Road Improvement fund and the issuance of bonds to the abutting property owners of Louisiana Street from 19th to 23rd Streets. Representatives of the Newlin-Mossbacher Company appeared before the Board, offering a 2 yird P. & H. at \$9,985.00 f.o.b. Milwaukee, with a trade-in offer of \$2.500.00, or in liew, \$2,500.00 in cash, which was accepted to be delivered on or about the twenty-second day of April, 1947.
