## RESOLUTION

WHEREAS the Board of County Commissioners of Douglas County, Kansas, finds it expedient and beneficial to enter into a contract with the State Highway Commission of Kansas pertaining to the preparation and approval of plans, the acquisition of Rights of Way and the construction and maintenance of certain highway improvements in Douglas County.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Douglas County, Kansas, in regular session assembled this 24th day of March, 1948, that said County Commissioners enter into and execute an agreement, for the purposes as herein provided, their contract made and executed on this 24th day of March, 1948, between the said Board of County Commissioners of Douglas County, Kansas, and the State Highway Commission of Kansas; and said County Commissioners do hereby confirm the provisions of said agreement.
