The Board of County Commissioners of Douglas County met in regular adjourned session, all members of the Board being present.

The delegation from Jefferson County met at 10:00 o'clock A. M., April 12, 1948, by appointment with the Board of County Commissioners of Douglas County, Kansas, to discuss the repairs for the bridge over the Kaw River located at Lecompton.

Those present were: Chairman Ed Johnson, Commissioner Elmer W. Ousdahl, Commissioner L. H. Griffith, of the Board of County Commissioners of Douglas County, Kansas, also E. E. Larson, County Engineer, and Robert B. Oyler, County Attorney, of Douglas County, Kansas, and Guy Shultz, Chairman, and Commissioners W. W. Detlor and G. E. Barnes of the Board of County Commissioners of Jefferson County, and Max Engle, County Engineer, and James Lester, County Attorney, of Jefferson County, Kansas.

After considerable discussion, the following resolution was adopted:

JOINT RESOLUTION

Lawrence, Kansas,
April 12, 1948.

WHEREAS, The Board of County Commissioners of Jefferson County, Kansas, and Douglas County, Kansas, have met at regular session on the above date for the purpose of discussing necessary repairs on the Lecompton bridge over the Kansas River between Jefferson County and Douglas County; and

WHEREAS, The following persons and officials are present at said meeting, Chairman Ed Johnson, Commissioner Elmer W. Ousdahl, Commissioner L. H. Griffith, of the Board of County Commissioners of Douglas County, Kansas, also E. E. Larson, County Engineer, and Robert B. Oyler, County Attorney, of Douglas County, Kansas, and Guy Shultz, Chairman, and Commissioners W. W. Detlor and G. E. Barnes of the Board of County Commissioners of Jefferson County, and Max Engle, County Engineer, and James Lester, County Attorney, of Jefferson County, Kansas, and;

WHEREAS, It is agreed between the Board of County Commissioners of said counties that repairs are necessary for said Lecompton bridge, such repairs to consist of a new deck and stringers, and such other material as is necessary to put said bridge in usable condition;

BE IT THEREFORE RESOLVED AND AGREED by the Board of County Commissioners of Jefferson County, Kansas, and the Board of County Commissioners of Douglas County, Kansas, in joint session duly assembled in the court house in the City of Lawrence, Douglas County, Kansas, that the cost of repairs upon said bridge during the year 1948 be borne as follows: forty five percent (45%) by Jefferson County, Kansas, and fifty five percent (55%) by Douglas County, Kansas; that the deck and stringers on said bridge shall be replaced with new creosote treated bridge planking; that the engineers estimated cost of repairs is \$14,300.00: That when running boards are placed upon said bridge at some future date, to be determined by said boards, the cost of placing the same thereon shall be borne on the same percentage basis set out above: forty five percent (45%) by Jefferson County, and fifty five percent (55%) by Douglas County: Provided that the engineering supervision shall be jointly done by both counties;

THEREAFTER, the above resolution was considered and discussed and after consideration and discussion, its adoption was moved by Commissioner Shultz, which motion was duly seconded by Commissioner Griffith, duly put by Chairman Ed Johnson, and declared to be carried unanimously.
