The Board of County Commissioners of Douglas County met in regular adjourned session, all members of the Board being present.

Additional bills for equipment and supplies were approved and allowed by the Board as per the Allowance Record.

Hearing for the petition from the Governing Body of the City of Lawrence to annex the property between Nineteenth and Twenty-First Streets West of Louisiana Street, consisting of 37½ acres, was held at 9:00 o'clock A. M. After proper motion, second, and on vote called, the Board allowed the petition, and the following resolution was adopted:

RESOLUTION OF BOARD OF COUNTY COMMISSIONERS OF DOUGLAS COUNTY, KANSAS

WHEREAS, the Governing Body of the City of Lawrence, Kansas, did on the 10th day of April, 1948, file with the County Clerk of Douglas County, Kansas, its petition to the Board of County Commissioners of Douglas County, Kansas, for authority and approval to enlarge the limits of the City of Lawrence, Kansas, by adding the following adjacent territory thereto:

The NE¼ of SE¼, Section 1, Township 13 South, Range 19 East, less the following: Beginning at the Southwest corner of NE¼ of SE¼, thence East 20 rods, North 20 rods, West 20 rods; thence South 20 rods to beginning, also described as follows: beginning at the Northeast corner of Section 1, Township 13 South, Range 19 East of 6th P.M.; thence West along the North line of Section 1, 1327.4 feet; thence to the left 89°-18', 996.3 feet; thence to the left 90°-42', 330 feet; thence to the right 90°-42', 330 feet; thence to the left 90°-42', 998.75 feet to the east line of Section 1; thence to the left 89°-22', 1326.45 feet to place of beginning, in Douglas County, Kansas

and to make a finding as to the advisability of adding said territory to said City, all as provided by 12-501 of R. S., 1935, and

WHEREAS, the said matter was duly set for hearing on the 5th day of May, 1948, at 9:00 o'clock a.m., in the Commissioner's room of the Court House of Douglas County, Kansas, in the City of Lawrence, Kansas, and

WHEREAS, notice of such hearing was duly published for three consecutive weeks as provided by law in the Lawrence Daily Journal World, the same being a newspaper of general circulation in said City, and

WHEREAS, on the aforesaid date and time and at the aforementioned place, the said Board of County Commissioners, all of the members of said Board being present, did proceed to hear testimony as to the advisability of making the addition requested in the above mentioned petition, as provided in 12-502 of R.S. 1935, and

WHEREAS, the said Board of County Commissioners, upon such hearing, did find that the adding of the above described property to the said City is to its best interest and will cause no manifest injury to the persons owning real estate in the territory sought to be added,

NOW, THEREFORE, be it resolved by the Board of County Commissioners of Douglas County, Kansas, in regular adjourned meeting this 5th day of May, 1948, all of the members of said Board being present, that the Governing Body of the City of Lawrence, Kansas, shall have and is hereby granted authority and approval to enlarge the limits of the City of Lawrence, Kansas, by adding thereto the adjacent territory as above described.
