Upon viewing the Paul Snyder property at 1613 Tennessee, the Board and the County Clerk found a regularly constructed cement, glass and steel green house, which is approximately 20x40 feet which has not been assessed and which Mrs. Snyder stated had been constructed in the last year. This property (Plate #3863) was not included in the protest when it was presented by Mr. Stevens and Mr. Brand. Mr. Griffith and Mr. Johnson stated they would back the County Clerk in this action.
