### Section Two

That from the proceeds of the sale of said bonds, the sum of \$3,242.00 shall be applied to the retirement of the principal and interest now payable on the aforesaid temporary notes dated February 1, 1947. That the balance of the proceeds from the sale of said bonds shall be used to pay such of the costs of said lateral sewer as have not been paid by the proceeds received from the sale of the temporary notes aforesaid.

# Section Three

That said bonds shall be dated August 1, 1948, and shall consist of eleven bonds numbered from one to eleven inclusive and shall bear interest at the rate of  $l_2^1$  per cent per annum and shall be of the denominations and maturities as follows:

#### Section Five

The said Chairman and said Clerk are hereby authorized to prepare and execute said bonds and coupons, and, when so executed, said bonds shall be registered as required by law and said County shall annually make provision for the payment of principal and interest of said bonds as the same shall become due by levying a tax upon the lots or parcels of land of said benefit district.
