The following Resolution was passed By the Board authorizing the Commonwealth Lawrence Theatre Company, a corporation, the right to lay a water main from 23rd and Louisiana Street south, resolution as follows:

## RESOLUTION

WHEREAS, the Board of County Commissioners of Douglas County, Kansas, have met at regular session on this 9th day of April, 1949, the following commissioners being present: Chairman Elmer W. Ousdahl, Commissioner Charles E. Banning, and Commissioner Ray C. Ogden; and

WHEREAS, on April 7, 1949, the Commonwealth Lawrence Theatre Company, a Corporation, duly organized and existing under the laws of the State of Kansas, has duly presented a petition to said Board of County Commissioners asking for authority has to lay, maintain and operate a water main to:

Beginning at the Southwest corner of the intersection of Louisiana and 23rd Streets in the City of Lawrence, Kansas, thence in a southerly direction along the West side of a township road of a distance of approximately 380 feet, thence in a westerly direction across real property owned by one Ralph Puckett

to a drie-in-theatre now under construction by said corporation.

WHEREAS, the Board of County Commissioners further finds that said corporation has authority and permission from the City of Lawrence, Kansas, to connect to the water main at the intersection of Louisiana and 23rd Streets in the City of Lawrence, Kansas; and

WHEREAS, said Board of County Commissioners further finds that said corpora-tion will lay, maintain, operate and repair said water main at its own expense and that it will further replace said public highway in as good a condition as it now is.

NOW THEREFORE BE IT RESOLVED by the Board of County Commissioners of Douglas County, Kansas, that the Commonwealth Lawrence Theatre Company, a corporation, that said corporation is hereby granted and given authority to lay, maintain, operate and repair a water main for a pedod not to exceed twenty-five years on or along the West side of a public highway for approximately 380 feet South of the intersection of Louisiana and 23rd Streets in the City of Lawrence, Kansas, upon the condition that should it be necessary to change or move said water main to repair or reconstruct a public highway on which said water main is placed, said corporation will remove its water main at its expense.
