The Board of County Commissioners of Douglas County met in regular adjourned session, Elmer W. Ousdahl and Ray C. Ogden being present.

County Engineer Joe I. Rice appeared before the Board in regard to Road and Bridge matters.

The Board instructed Robert B. Oyler, County Attorney, to have the Convalescent Home lots rezoned by the City Council into another zone from residence, lots as follows:

Lots 41, 43, and 45 on Elliott Street (4th), and Lots 75, 77, 79, 81, 83, 85, 87, 89, and the East 25 feet of South half of Lot 86, and the East 25 feet of Lots 88 and 90, all in Block 21 in the City of Lawrence, Douglas County, Kansas, known as West Lawrence.

Welfare Director Mildred Watson appeared before the Board to discuss matters pertaining to Welfare.

The Board voted to increase the amount for printing of the Delinquent Tax List and the Judicial Tax Sale Notice ten per cent (10%), or from twenty (20) cents to twenty-two (22) cents per description, and from nine (9) cents to ten (10) cents per town lot. A ten per cent (10) increase was allowed as of January 12, 1949, on bills allowed and legal notices, or from seven and one-half (7½) cents to eight and one-fourth (8¼) cents per line.
