Additional bills for equipment and supplies were approved and allowed by the Board as per the Allowance Record.

The Sheriffs allowance for feeding prisoners was increased ten cents  $(10\phi)$  per prisoner per day, motion by Ogden, seconded by Banning, and on vote called motion carried.

## RESOLUTION

WHEREAS, the Board of County Commissioners of Douglas County, Kansas, has met at regular session this 6th day of August, 1949, the following commissioners being present: Chairman, Elmer W. Ousdahl, Commissioner, Charles E. Banning, and Commissioner, Ray C. Ogden.

WHEREAS, the Board of County Commissioners now finds that it is expedient and to the best interest of Douglas County, Kansas, that any interest said county has in and to the following described road, to-wit: and to the

Beginning at a point 30 feet east of the Northwest corner of the Northeast Quarter, Section 6, Town-ship 13 South, Range 20 East, thence East 140.5 feet; thence South 30 feet; thence West 140.5 feet; thence North 30 feet to beginning, being the South Half of county road at 15th Street and Barker to Connecticut Street, in Douglas County, Kansas

should be released, conveyed and quit claimed unto the City of Lawrence, Kansas, and that the said Board of County Commissioners of Douglas County, Kansas. should be released from any further liability in regard to the upkeep, care and repair of said road .

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Douglas County, Kansas, that said county remise, release and quit claim and assign to the City of Lawrence, Kansas, any estate, title and interest that said Board of County Commissioners of Douglas County, Kansas, has in and to said above described road, and that said resolution be spread on the records of the County Clerk's office of Douglas County, Kansas, as provided by Section 19-310 of the General Statutes of Kansas for 1935, and that a certified copy of this resolution be sent to the City of Lawrence, Kansas, for its acceptance of the above described road and upon their acceptance of said road, the Board of County Commissioners of Douglas County, Kansas, we released of any further upkeep, care or repair of said road.
