WHEREAS, it is provided by Chapter 203, Laws of Kansas, 1949, that the Board of County Commissioners shall by resolution place and pay a bounty of two (2) dollars for the scalp with both ears attached of each coyote or wolf caught and killed in such county,

NOW, THEREFORE, BE IT RESOLVED that the Board of County Commissioners of Douglas County shall pay bounty as follows: ten cents  $(10\phi)$  for each gopher or crow head caught and killed in Douglas County, and two (2) dollars for the scalp with both ears attached of each coyote or wolf caught and killed in Douglas County, said bounty to be paid out of the bounty fund as set up in the approved county budget.
