The Board of County Commissioners of Douglas County met in regular adjourned session, all members of the Board being present.

The Board discussed Road & Bridge matters with County Engineer, J. I. Rice.

The Board closed a road from a point 1770 feet North of quarter corner between Sections 35 and 36, Township 12, Range 20 East, thence North to the Kansas River. Land on both sides of the abandoned road belongs to O. N. Altenbernd. The following resolution to that effect was passed by the Board:

RESOLUTION

WHEREAS, The Board of County Commissioners of Douglas County, Kansas, unanimously find that it would be to the best interests of Douglas County, Kansas, to close Road No. (This road has no former number) as provided in Section 68-102 of the Revised Statutes of Kansas, 1945.

Beginning at a point 1770 feet North of the quarter corner between Sections 35 and 36, Township 12 South, Range 20 East, thence North to the Kansas River. The land on both side of said Vacation to the Kansas River is owned by Mr. O. H. Altenbernd, and asked for by Mr. Altenbernd.

ADOPTED this 18th day of January, 1950, by the Board of County Commissioners of Douglas County at a regular session held in Lawrence, Kansas.
