Beginning at the SouthWest corner of Section 25, Township 12 South, Range 17 East, thence North 1 mile to the NorthWest corner of said Section 25. (Asked for by the Board of Trustees of Kanwaka Township.)

Road No. 622, beginning at the 1/4 corner on the North line of Section 22, Township 12 South, Range 18 East, thence East to a point 1650 feet West of the NorthEast corner of said Section 22. (Asked for by the Trustees of Kanwaka Township.)
