RESOLUTION

WHEREAS, The Board of County Commissioners of Douglas County, Kansas, unanimously find that it would be to the best interest of Douglas County, Kansas, to close Road No. 496 as provided in Section 68-102 of the Revised Statutes of Kansas, 1945.

Begin at a stake 10.47 chains East of the Southwest corner of Section 23, Township 14 South, Range 20 East of the 6th P.M.
Thence variation 80° 50' East, North 38° 30' West 1300 chains to a stake 20 feet East of the West boundary of Section 23 and 8.05 chains North of the S.W. corner of said Section 23. Thence North parallel with and 20 feet from the West boundary of Section 23. 28.70 chains to a stake in the left bank of Coal Creek. Thence North 52° 20' West down stream along the bank of Coal Creek 5.00 chains to a stake 20 feet South of the north boundary of the Southeast quarter of Section 22. Thence West parallel with the North boundary of the Southeast quarter of Section 22. 35.92 chains to a stake 20 feet South of the center quarter section corner in Section 22 in Township 14 South of Range 20 East. (Asked for by Palmyra Township Board.)
