TRACT I

Begin at a point on the South line of Stratford Road, 990 feet East and 305 feet North of the Southwest corner of the North one-half of Southwest quarter of Section 36, Township 12 South, Range 19 East of the 6th P.M.; thence West on the South line of Stratford Road as extended West 323.5 feet; thence North 120 feet; thence East 60 feet; thence South 70 feet; thence East 263.5 feet; thence South 50 feet to place of beginning, in Douglas County, Kansas.

TRACT II

Begin at a point 203.75 feet West of the Southwest corner of the Southwest quarter of the Southeast quarter of Section 32, Township 12 South, Range 20 East of the 6th P. M., said point being the Southeast corner of Belmont Addition to the City of Lawrence; thence East to the Southeast corner of the southwest quarter of the Southeast quarter of said Section 32; thence North to the Northeast corner of the Southwest quarter of the Southeast quarter of said Section 32; thence West to the Northwest corner of the Southwest quarter of the Southeast quarter of said Section 32; thence South 46 feet; thence West 363 feet, said point being the Northeast corner of Lot 12 Fairfax Addition to the City of Lawrence also being on the East line of Elmwood Street extended North; thence South along the East line of Elmwood Street 805.75 feet to the South line of Oak Hill Avenue; thence Easterly along the South line of Oak Hill Avenue 162.5 feet, said point being the Northeast corner of Belmont Addition to the City of Lawrence; thence South along East line of Belmont Addition to place of Beginning, in Douglas County, Kansas.

TRACT III

Begin at the Northwest corner of Section 7, Township 13 South, Range 20 East of the 6th P. M.; thence South to the Southwest corner of the Northwest quarter of said Section 7; thence East to the Southeast corner of the West one-half of the Northwest quarter of said Section 7; thence continuing East 69.5 feet more or less to a point on the West line of Breezedale Addition as produced South; thence North 1662.38 feet more or less to the Southwest corner of Breezedale Addition; thence continuing North on the West line of Breezedale Addition to the North line of Section 7; thence West to place of beginning in Douglas County, Kansas,

and requests of said commissioners to make a finding as to the advisability of adding said above described tracts to said City.
