COMMISSIONER'S RECORD O

4. Washing or throwing of waste of any kind around water faucets or fountains or the use of woods as toilets, or the use of toilets as bath houses is prohibited.

5. Building or starting fires in the open or in any place except where the proper provisions have been made is prohibited.

6. Dogs in the park must be tied with a chain or controlled by a leash. They are not allowed to run loose about the park.

Speed limit on park roads for vehicles is 25 miles per hour except where otherwise posted

8. Horseback riding or driving automobiles or other vehicles on picnic children's playgrounds, and areas posted against such traffic or use is 8 grounds. prohibited.

9. Camping in the park is prohibited except in the area set aside for organized youth groups to be used only by special permission secured from the Lone Star Lake Park Superintendent. Groups using camp must comply with park regulations and in addition must conform with the required minimum standards for use of the cam the camp.

10. Disorderly conduct in the way of drunkenness, vile language, fighting and personal exposure by change of clothing in automobiles, woods, park or any other place where person is not properly sheltered is prohibited.

11. Bathing, swimming or wading is prohibited with the exception that wading with boots during open fishing season will be permitted.

12. Lone Star is a game sanctuary. Hunting, shooting, killing, trapping, , pursuing, or molesting in any way any bird or animal on or within the park injuring. is prohibited.

13. Fishing in Lone Star Lake is prohibited except under such rules and regulations as hereinafter set out by the Board of County Commissioners of Douglas County, Kansas.

14. The use of water craft is prohibited except under such rules and regulations as hereinafter set out by the Board of County Commissioners of Douglas County, Kansas.

15. The park superintendent is a deputy sheriff and is assisted by special deputies to preserve order and make arrests for violations of rules.

16. 17. The use of intoxicating liquors on park premises is prohibited. Shelter houses may be reserved upon application to the caretaker.

RULES AND REGULATIONS PERTAINING TO FISHING

1. It shall be unlawful to fish in Lone Star Lake without having first obtained from the county clerk, or superintendent of the lake, as hereinafter provided, a proper license or permit from said county, and paying the required fee.

2. The fee required to be paid for a season fishing license to expire on June 30th of each year shall be one dollar (\$1.00), or twenty-five cents (25ϕ) for a permit issued for a specified day.

3. Every person must possess a Douglas County fishing license or permit to fish in Lone Star Lake is over 16 years of age and under 70 years of age. Permits will be issued only to the holder of a state fishing license.

4. It shall be unlawful for any license or permit holder to alter, lend, transfer his license or permit, and it shall be necessary for each license or permit holder to exhibit his license on demand of any officer or duly authorized agent of t county or state. or the

5. It shall be unlawful for any person to fish in Lone Star Lake with more than two poles with two hooks each or to fish in any part of said lake where "No Fishing" signs have been posted. Fishing with a seine, throwline, trotline, spear, hand fishing or any other method than with a pole and line is illegal.

6. The size, limit, and number of fish that may be caught and removed from the lake in any one day shall be as follows:

Daily bag limit: Bass 10 inch minimum 12 inch minimum Channel Cat Total bag equals 10 of bass and channel; and 10 on other species.

RULES AND REGULATIONS PERTAINING TO BOATS AND BOATING

1. It shall be unlawful to operate any boat upon Lone Star Lake hereinafter referred to as the Lake, unless duly licensed as hereinafter provided, and then only in strict accordance with this resolution: The word "boat" shall include canoe, rowboats, sailboats and power boats.

2. All persons keeping, maintaining, operating or riding in boats on the lake do so entirely at their own rish.

3. Persons desiring to keep, have and maintain any boat upon the lake shall make application for that privilege to the Superintendent of the Lake, stating the name of the boat owner, the type, size, capacity, condition and general description of the boat, and furnish proof that the craft is in a safe condition. Upon receipt of license, licensee must display the license number issued him upon said boat.
