The above described territory does constitute a public corporation and the inhabitants within such boundaries are hereby incorporated as a drainage district under the name of the Wakarusa-Kaw Drainage District of Douglas County, Kansas,

And it is further ordered by the Board that the time and place of holding the first election to choose three Directors of such Drainage District be set and fixed as follows:

On the 27th day of October, 1951, between the hours of 8:00 A. M. and 6:00 P. M. in the following named place; Kaw Valley School Number 12, Douglas County, Kansas, situated within said Drainage District as heretofore described.

And the following resident tax payers residing within said drainage district are hereby designated to act as judges and clerks, to wit:
