Beginning at a point at the center of 13th Street, 160 feet west of the Northeast corner of Plat of Spencer Heights; thence South along the center of Spencer Drive, parallel with the East line of Plat, 414.1 feet; thence on a curve to the East with a radius of 177 feet for a distance of 170 feet; thence on a compound curve to the left, having a radius of 100 feet 90 feet more or less to the East line of Plat.

Also beginning at the center line of a public road being the West limit of Spencer Height, 270 feet from the Northwest corner of same for a point of beginning; thence East at right angles, the distance of 70 feet; thence on a curve to the right with a radius of 200 feet and a distance of 214 feet being along the center line of Hillcrest Road; thence on a tangent line 108 feet; thence on a curve to the left with a radius of 123 feet for a distance of 336 feet, more or less, to join the center line of Spencer Drive West of Lot #4.
