September 11, 1952.

The Board of County Commissioners of Douglas County met in regular adjourned session, with all members present, to discuss the conditions existing above the Kaw River Bridge at Eudora. Present were Commissioners Rush, Eshelman, Hall and County Engineer Parr and County Attorney Boone of Leavenworth County, together with J. I. Rice, County Engineer of Douglas County.

County Engineer Parr of Leavenworth told of his conference with the U. S. Engineers at Kansas City, Missouri, saying that they would participate to the extent of \$50,000, and their estimated plans for improvements amounting to \$150,000 which would include two stone jetties and dredging operation, along with some minor jetties.

Doubt was expressed by both Boards of being financially able to undertake such a project, but the members were of the opinion the Boards should attempt to obtain a consulting Engineer to take soundings, draw maps, estimate the cost of dredging and do other work necessary to get a clear picture of what should be done and what the cost would be of the plans. J. I. Rice of Douglas County is to find an engineer who would do the work as outlined for a reasonable fee, Leavenworth County to be furnished minutes of the meeting, and estimated cost of plans.
