own and maintain the Eudora Bridge and road rights-of-way for a highway between the counties over the Kansas River;

WHEREAS, the southerly bridge approach of the Eudora bridge is subject to flood damage and emergency bank protection works are required to prevent such damage;

WHEREAS, the Counties plan certain diversion works and bank stabilization in the vicinity of said bridge;

WHEREAS, a contract between the United States of America and the County Commissioners of Leavenworth and Douglas Counties, State of Kansas, specified as Contract No. DA-23-028-ENG-1783, is being considered whereby the United States of America will participate in the proposed work to an amount not exceeding \$50,000, pursuant to Section 14 of the 1946 Flood Control Act;

WHEREAS, in addition to the terms and conditions which are to be included in the proposed contract, the District Engineer, Corps of Engineers, Kansas City District, prior to the execution of the proposed contract and initiation of the work, has requested certain assurances from the Counties,

NOW THEREFORE BE IT RESOLVED THAT the County Commissioners of Leavenworth and Douglas Counties, State of Kansas, furnish the required assurances designated below, that these bodies will cooperate with the Federal Government and its designated authorities and agents:

a. That the Counties of Leavenworth and Douglas State of Kansas, agree to provide, without cost to the United States, all lands, permits and licenses required for the construction and maintenance of the proposed work,

b. That the afore-mentioned counties will hold and save harmless the United States from damage due to the construction work,

c. That the afore-mentioned counties will provide normal future inspection and maintenance of the completed work such as:

- (1) The replacement of damaged piles and structure ties in the pile structure.
- (2) Maintenance of the rock structures to their original grade and cross-section, (3) and accomplishing any work necessary to prevent flanking of the stabilization structures and such work incidental thereto which may be necessary to maintain the new channel alignment, all in a manner satisfactory to the Chief of Engineers, Corps of Engineers.
