In consideration of \$1.00 and a deed, signed and executed by Lillian Murphy formerly Lillian Adams, and H. J. Murphy, her husband, in favor of Douglas County, Kansas, for the following described tract of Land:

Commencing 283 feet 6 inches West of the West line of A.T. & S. F. R.R., on the South line of Southwest quarter of Section Ten, in township fourteen, Range Twenty, thence North 269 Feet, thence West 50 feet, thence South 269 feet, thence East 50 feet to the place of beginning, in Douglas County, Kansas, which said deed is recorded in Deed Book 180, on page 556, in the office of the Register of Deeds, Douglas County, Kansas.

The Board of County Commissioners of Douglas County Kansas executed a quit claim deed in favor of The Church of Christ of Vinland, Kansas, for a tract of ground described as follows: Beginning at a point 111.0 feet East of the Southwest of Southwest Quarter of Section ten, in township 14, Range 20, thence east 75 Feet, thence North 264 Feet thence West 186 feet to the West line of said Southwest Quarter, the South 124.5 feet, thence East 111.0 feet, thence South 139.5 feet to the point of beginning, containing .75 Acres, in Douglas County, Kansas.
