The Board of County Commissioners of Douglas County met in regular adjourned session with all members of the Board present.

George Criss, Chairman of the viewers on the extension of East 19th Street, recommended the petition be denied and the road should be made a private road according to the specifications stated in the recommendation.

The date of viewing on the C. W. Davenport road petition is set for August 9, 1954.

The Board then met in a joint session with the Leavenworth County Commissioners and after due consideration passed a joint resolution to repair rock jetty #2 on the Eudora Bridge Protection:

Joint resolution of board of county commissioners of Douglas County, Kansas, and the Board of County Commissioners of Leavenworth County, Kansas.

WHEREAS, on this 19th day of July, 1954, the same being a regular meeting date for the Board of County Commissioners of Douglas County Kansas, said Board met jointly with the Board of County Commissioners of Leavenworth County, Kansas, in the Douglas County, Kansas Court House, Lawrence, Kansas, and WHEREAS, said joint Boards of County Commissioners of Douglas and Leavenworth Counties, Kansas, examined a requirement made by the Corps of Army Engineers, U. S. Army, said requirement having been dated June 29, 1954, and signed by John T. Poffenberger, Lt. Col., Corps of Engineers, Executive Officer, and said requirement relating to the terms of Article 3a of Contract No. DA-23-028-eng-1783, whereby the U. S. Government participated in a certain project referred to as the Eudora, Kansas Bridge Protection Project. Said Corps of Engineers' requirement, in reference to the above described contract, required that necessary action be taken on Rock Dam No. 2 of said project to repair an existing hole in said Rock Dam No. 2.

WHEREAS, SAID JOINT Boards of County Commissioners of Douglas and Leavenworth Counties, Kansas, have caused an inspection to be made by their respective County Engineers of Rock Dam No. 2 and find that a hole does exist in said dam and that further deterioration in said dam is likely to result unless proper action is taken to repair said hole. Said Boards further find that they are bound and obligated under the terms of the government contract hereinbefore mentioned to make the necessary repairs on Rock Dam No. 2 and further that such repairs should be made to re-establish the former effectiveness of said dam.
