

COMMISSIONER'S RECORD O

AND WHEREAS, a written offer has been submitted by Perry Jones, Carbondale, Kansas, to make the necessary repairs on said Rock Dam No. 2 for the sum of \$1.50 per ton for quarry run rock to be placed in the appropriate and necessary locations to repair the hole now existing in said Rock Dam No. 2 and said Boards find that the written offer of Perry Jones should be accepted and said Boards hereby authorize their respective chairmen to enter into a contract with the said Perry Jones to repair the hole existing in Rock Dam No. 2 for the consideration of \$1.50 per ton for quarry run rock properly put in place on said Rock Dam No. 2.

AND WHEREAS, said joint Boards of County Commissioners of Douglas and Leavenworth Counties, Kansas, find that each of said counties will be bound and pay one-half of the total cost of said repairs to Rock Dam No. 2.

THEREFORE, BE IT RESOLVED' on this 19th day of July, 1954, by the joint Boards of County Commissioners of Douglas and Leavenworth Counties, Kansas, that necessary repairs be made to Rock Dam No. 2, said dam being a part of the Eudora, Kansas Bridge Protection Project and that a written offer of Perry Jones, Carbondale, Kansas, to repair said dam for the consideration of \$1.50 per ton for quarry run rock properly put in place on said dam, be accepted and the respective chairmen of the Boards of County Commissioners of Douglas and Leavenworth Counties, Kansas, be authorized to enter into an agreement with the said Perry Jones to make said repairs.

BE IT FURTHER RESOLVED that the Boards of County Commissioners of Douglas and Leavenworth Counties, Kansas, hereby acknowledge and bind their respective counties for one-half of the total cost of repairs of said Rock Dam No. 2.

The Chairmen of both Boards signed a contract with Perry Jones to repair Rock Jetty #2 on the Eudora Bridge Protection Project:

A G R E E M E N T

These Articles of Agreement made and entered into this 19th day of July, 1954, by and between the Board of County Commissioners of Douglas County, Kansas, and the Board of County Commissioners of Leavenworth County, Kansas, hereinafter referred to as parties of the first part, and Perry Jones, an individual, of Carbondale, Kansas, hereinafter referred to as Party of the Second Part, WITNESSETH:

In consideration of mutual covenants and conditions herein contained by the parties hereto, it is agreed as follows:

That the parties of the first part will pay to party of the second part the sum of \$1.50 per ton for quarry run rock, said rock to be put in place on Rock Dam No. 2, the same being part of the Eudora, Kansas Bridge Protection Project, and that party of the Second part, in consideration of the sum of \$1.50 per ton for quarry run rock furnished to Rock Dam No. 2, as aforesaid, will furnish all necessary labor and equipment required to place said rock in the hole now existing between approximate stations 9-00 and 10-00 on said Dam No. 2.

It is further mutually understood and agreed between the parties hereto that party of the second part is an independent contractor and is accepting the work to be performed under this agreement as such an independent contractor and not as an employee of parties of the first part. The parties hereto also agree that the consideration, to be paid as above provided, shall not be due and payable until the work to be performed hereunder has been approved by the County Engineers of both Douglas and Leavenworth Counties, Kansas, and that said work is to be completed within a reasonable time from the date hereof, time of completion of the work being of the essence of this Agreement.

It is further mutually agreed and understood that these Articles of Agreement have been entered into by parties of the first part after a legal joint meeting of the Boards of County Commissioners of Douglas and Leavenworth Counties, Kansas, which meeting resulted in a Resolution by the joint boards of County Commissioners of said counties authorizing said work, said work having been required by the Corps of Engineers.
