WHEREAS, the Board of County Commissioners of Douglas County Kansas, has met at a regular session on this 15th day of December 1954, the following Commissioners being present: Chairman Elmer V Ousdahl, Commissioner Charles E. Banning, and Commissioner Ray C. Ogden.

WHEREAS, WHEREAS, the Board of County Commissioners now finds it advisable to provide additional compensation to all county officers, their deputies, assistants and employees, except employees of the Welfare Department of Douglas County, Kansas, which said employees are regulated by Civil Service requirements and consequently not included herein. Said Commissioners further find that said additional compensation shall be paid to all elective county officers in the amount of five percent of the salary fixed by Statute for each such elective officer, and that all other employees, namely, deputies, assistants and employees, shall receive a flat salary increase of Ten Dollars (\$10.00) per month, after each of said deputies, assistants and employees have been employed by Douglas County, Kansas, continuously for one year.
