compensation herein provided shall augment the total salary of each County Officer, deputy, assistant and employee and be paid in addition to the salary schedule resolved on the 30th day of April, 1955.

Any elective officer who holds two or more county offices shall receive the additional compensation herein provided as five per cent (5%) of the salary of the office to which he was elected and shall receive no additional compensation for the other office or offices which he holds.

That such additional compensation shall be paid in equal monthly installments and shall become effective and operative on September 1st, 1955, and shall be paid even though such expenditure was not included in the County budget for the period for which such additional compensation was paid.

The Commissioners hereby find and determine that this Resolution is authorized by House Bill No. 73 of the 1955 Legislature and that said Bill by specific provisions therein, provides that such salary increases or additional compensation shall be in addition to and not conflict with any of the provisions of Chapter 28 of the General Statutes of Kansas, 1949, or the 1953 Supplement thereto or any other statute prescribing compensation for county officers, deputies, assistants or employees nor shall it repeal any law except those specifically repealed by such act, those being Sections 28-157 (a), 28-157 (b), 28-157 (c), or 28-157 (d), of the 1953 Supplement to the General Statutes of Kansas, 1949.

The Board of County Commissioners find and determine that this Resolution is necessary in order to meet the costs of living increase experienced within Douglas County, Kansas, and further, that they intend by this Resolution to comply strictly with the terms and conditions of House Bill No. 73 of the 1955 Legislature.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Douglas County, Kansas, that salary increases or additional compensation is hereby allowed to all county officers, their deputies, assistants or employees in the amount and upon the conditions following: All elective county officers are hereby granted increases in the amount of five per cent (5%) of the salary fixed by statute for such officer and all other deputies, assistants or employees, of permanent classification, are hereby allowed a flat salary or compensation increase of \$10.00 per month, except the employees of the Sheriff's office of Douglas County, Kansas, who shall receive a flat salary increase of \$20.00, after each of said deputies, assistants, and employees have been employed by Douglas County, Kansas, continuously for a period of one year. That said increases shall be paid for services rendered on and after September 1st, 1955, and shall remain in full force and be effective for services rendered up to and including June 30th, 1956. That where any elective officer holds two or more county offices, the five per cent (5%) additional compensation herein provided shall apply only to the salary as fixed by statute, for the office to which said officer was elected and shall not apply to salaries paid to said officer for other than the one office to which he was elected. Such additional salary or compensation shall be paid to elective officers, as hereinbefore provided, and that all deputies, assistants and employees, and in the amount and upon the conditions hereinbefore provided, in equal montjly installments, beginning with September 1st, 1955, and ending June 30th, 1956, and shall be paid even though such expenditures were not included in the County Budget for the period for which such additional compensation was paid.

BE IT FURTHER RESOLVED, by the Board of County Commissioners of Douglas County, Kansas, that this Resolution and each and every provision thereof is adopted with the sole and specific intent of granting salary or compensation increases necessitated by cost of living increases and authorized by House Bill No. 73, of the 1955 Legislature, which said House Bill No. 73 by its own terms, provides that such salary increases or additional compensation shall be in addition to and not conflict with any other provisions of Chapter 28, of the General Statutes of Kansas, 1949, or the 1953 supplement thereto, or any other statute prescribing compensation for county officers, deputies, assistants or employees or shall it repeal any laws other than those specifically repealed by such act, those being Section 28-157 (a), 28-157 (b), 28-157 (c), 28-157 (d), of the 1953 Supplement to the General Statutes of Kansas, 1949, and is the further intention of the Board of County Commissioners of Douglas County, Kansas, to fully and strictly comply with the authority, discretion, terms and conditions granted said County Commissioners by the enactment of said House Bill No. 73.
