WHEREAS, the Board of County Commissioners find that it is necessary to purchase pumps for the County wells for the reason that this is a drought area and the present pumps are no longer usable; that this expenditure was not foreseen and was not budgeted in the surrent budget; that Section 79-2939, G.S. of Kansas, 1949, author-izes the Board of County Commissioners to make application to the State Commission of Revenue and Taxation to issue no fund warrants, for emergency situations; that the Board of County Commissioners, deem this an emergency situation and that no fund warrants should be issued in the amount of \$3,000.00 to purchase and replace the pumps.
