RESOLUTION

Whereas, the Board of County Commissioners now find it advisable after viewing the same, to vacate the following described road for the reason of non-use:

Beginning at a point in road No. 545 on the East line of Southeast $\frac{1}{4}$ of Section 7, Township 12, Range 18, thence West on alignment of road 545 to a point 100 feet North of the $\frac{1}{4}$ corner on the South line of said Section 7.

The Commissioners hereby find and determine that this Resolution is authorized by Section 68-102 and 68-102 (a) of the G.S. of Kansas 1949.

BE IT FURTHER RESOLVED, that the County Clerk prepare an Order for the vacating of the above road and post the same in three conspicuous places along said road.
