WHEREAS, the Board of County Commissioners after being well and fully advised find that it would be to the best interests of the County to transfer \$37,000.00, which is an amount not in excess of 25% of money credited to the road and bridge fund to a special road, bridge or street building machinery, equipment and bridge building fund, all, as provided in Section 68-141 (g) of the 1953 Supplement to the General Statutes of Kansas, 1949.

NOW, THEREFORE, BE IT RESOLVED, by the Board of County Commissioners of Douglas County, Kansas, that \$37,000.00 which is an amount not to exceed 25% of the amount of money credited to the road and bridge fund be transferred to a special road, bridge or street building machinery, equipment and bridge building fund.

BE IT FURTHER RESOLVED that a copy of this Resolution shall be delivered to the County Treasurer and said Treasurer shall credit an amount of \$37,000.00 of the money credited to the road and bridge fund to a special road, bridge or street building machinery, equipment and bridge building fund. That the adoption of this Resolution is authorized by and is in conformity with Section 68-141 (g) of the 1953 Supplement to the General Statutes of Kansas, 1949, and further that all money credited to such special fund as set up by the adoption of this Resolution shall be used for the purpose of purchasing road, bridge, or street building machinery or equipment, or the building of bridges subject to the hereinbefore cited statute.

Petition to Enlarge Boundaries

To The Honorable County Commissioners,
County of Douglas,
State of Kansas. October 30, 1956.

The Governing Body of the City of Lawrence, hereby petitions the Board of County Commissioners for authority and approval to enlarge the limits of the City of Lawrence, by adding the following adjacent territory thereto:

"Exhibit 'a' - Beginning at a point 300 feet East of the Southwest corner of the Southeast quarter of Section 19 Township 12 South, Range 20 East, on the south line of said Section 19, thence North 1825.3 feet to the South line of the Kansas Turnpike Authority right-of-way; thence West 300 feet to the East line of the Southwest Quarter of said Section 19, thence North 459 feet to a point 366 feet South of the Northeast corner of the Southwest Quarter of said Section 19, said point being on the South right-of-way line of the Kansas Turnpike Authority, thence Southwesterly along the South line of the Kansas Turnpike Authority right-of-way 772 feet to the West right-of-way line of the Union Pacific Railway, thence South 25 feet, thence Southwesterly along the South right-of-way line of the Kansas Turnpike Authority to the center of the Kansas River, thence Southerly along the center line of the Kansas River to the South line of Section 19, Township 12 South, Range 20 East, thence East to the point of beginning, Containing 82.5 Acres more or less."
