

and that this salary increase Resolution is for the purpose of validating such increases under the existing authority of House Bill #73. Further, that the increase herein provided shall be for the period of time extending from January 1, 1957, up to and including December 31, 1957. That no such additional compensation shall be paid for services rendered after December 31, 1957, that the additional compensation herein provided shall augment the total salary of each county officer, deputy, assistant and employee, and be paid in addition to the base salary for each of said officer, deputy, assistants and employees, as established by the laws in this State.

Any elective officer who holds two or more county offices shall receive the additional compensation hereinbefore provided as five percent of the salary for the office to which he was elected and shall receive no additional compensation for the other office or offices which he holds.

That such additional compensation shall be paid in equal monthly installments and shall be come effective and operative on January 1st, 1957.

The Commissioners hereby find and determine that this Resolution is authorized by House Bill #73, of the 1955 Legislature and that said Bill, by specific provisions therein, provides that such salary increases or additional compensation shall be in addition to and not conflict with any of the provisions of Chapter 28 of the General Statutes of Kansas, 1949, or the 1955 Supplement thereto or any other statute prescribing compensation for County officers, deputies, assistants or employees, nor shall it repeal any law except those specifically repealed by such act, those being Sections 28-157 (a), 28-157 (b), 28-157 (c) or 28-157 (d), of the 1953 Supplement to the General Statutes of Kansas, 1949.

The Board of County Commissioners find and determine that this Resolution is necessary in order to meet the cost of living increases experienced within Douglas County, Kansas, such increases having been previously granted by former Resolutions and being vitalized by this Resolution and being necessitated by the repeal of the statutes under which the previous raises or increases were authorized and that said Board of County Commissioners specifically intend by this Resolution to comply strictly with the terms and conditions of House Bill #73 of the 1955 Legislature.

NOW THEREFORE, BE IT RESOLVED, by the Board of County Commissioners of Douglas County, Kansas, that salary increases or additional compensation is hereby allowed to all county officers, their deputies, assistants or employees in the amount and upon the conditions following: All elective officers are hereby granted increases in the amount of 15% of the salary fixed by the laws of the State of Kansas for such officer and all other deputies, assistants, or employees, of permanent classification, are hereby allowed a flat salary or compensation increase of \$10.00 per month to those deputies, assistants or employees who have been employed continuously by Douglas County, Kansas, for a period of one year. That said increases shall be paid for services rendered on and after January 1, 1957, and shall remain in full force and be effective for services rendered up to and including December 31, 1957, that the increases or additional compensation herein provided shall be exclusive of all increases previously granted under the authority of the statutes repealed by House Bill #73, and that the effect of this Resolution is to keep the salaries at the same and exact figure as they have been immediately prior to said January 1, 1957. That where any elective officer holds two or more county offices, the 15% additional compensation herein provided shall apply only to the salary as fixed by statute, for the office to which said officer was elected and shall not apply to salaries paid to said officer for other than the one office to which he was elected. Such additional salary or compensation shall be paid to elective officers, as hereinbefore provided, in equal monthly installments, beginning with January 1, 1957, and ending December 31, 1957.

BE IT FURTHER RESOLVED by the Board of County Commissioners of Douglas County, Kansas, that this Resolution and each and every provision thereof, is adopted with the sole and specific intent of granting salary or compensation increases necessitated by cost of living increases which previously have been in force and which by this Resolution, are to be continued at the same rate and in the same amounts as the salaries of such officers, deputies, assistants and employees were established prior to January 1, 1957 that House Bill #73, by its terms authorized the increases herein provided and further provides that such increases shall be granted in addition to and not in conflict any of the provisions of Chapter 28 of the General Statutes of Kansas, 1949, or amendments thereto, except for those statutes specifically repealed by said House Bill #73. It is the further intention of the Board of County Commissioners of Douglas County, Kansas, to fully and Strictly comply with the authority and discretion granted said Board of County Commissioners by the enactment of House Bill #73.
