The Board of County Commissioners of Douglas County met in regular adjourned session with all members of the Board present.

The Board discussed road matters with the County Engineer, L. D. Rice.

Owen Mitchell and Carl Miller, of Wakarusa Township, appeared before the Board to discuss assessment matters.

A resolution was approved for Baldwin City and Eudora City to care for own streets.

Resolution

WHEREAS, THE Board of County Commissioners of Douglas County, Kansas, has met at a regular session this 8th day of June, 1957, the following Commissioners being present: Chairman, Elmer W. Ousdahl, Will H. Hayden Commissioner, and Walter Kampschroeder, Commissioner.

WHEREAS, the Board of County Commissioners now finds that it is expedient and to the best interest of Douglas County, Kansas, that the following described connecting link in the Douglas County Highway System be maintained by the City of Baldwin in said County and State under the authority of Section 68-506e of the General Statutes of Kansas, 1949, at the rate of \$250.00 per mile for the maintenance of said connecting link. The Commissioners further find that said after described connecting link has been maintained by Douglas County, Kansas, such funds for the maintenance of said strip being derived from the County and Township Road Fund. Further, that effective on July 1, 1957, the following described connecting highway link located within the City of Baldwin, Kansas, shall be maintained by said City and that said County shall pay to said City the sum of \$250.00 per mile for the maintenance of said connecting link, said \$250.00 be be paid quarterly to said City and said moneys to be credited to the Street and alley Fund of the City of Baldwin, Kansas.

The following described road, a connecting link, is described as follows: to-wit:

Beginning at a point 80.3 feet East of the Northwest Corner of Section 10, Twp. 15 South, Range 20 East, (being the centerline of the South end of 6th street in the City of Baldwin, Kansas); thence North on centerline of 6th Street one (1) mile to the Northwest Corner of Section 3, Twp. 15 South, Range 20 East (being the North end of 6th Street in the City of Baldwin, Kansas).

Also beginning at the center Quarter Corner of Sec. 3, Twp. 15 South, Range 20 East (being the centerline of the East end of High Street in the City of Baldwin, Kansas); thence West on the centerline of High Street one half (½) mile to the intersection of 6th Street in the City of Baldwin, Kansas. Total length of connecting links in the City of Baldwin, Kansas, is one and one-half (1½) Mi.

And that Douglas County, Kansas, should be and is released from any further obligation to maintain, care for, or repair the above described roadway other than the payment of the \$250.00 per mile allowance hereinbefore mentioned.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Douglas County, Kansas, that said County elects to pay the City of Baldwin, Kansas, the sum of \$250.00 per mile for the maintenance, upkeep and repair of the above described roadway, said payments to be made quarterly to said City of Baldwin and to be credited to the Street and Alley Fund of a said City, and thereby eliminate and relieve Douglas County, Kansas, from the obligation to maintain, care for and repair said roadway, except as hereinbefore provided and authorized by Section 68-506e of the General Statutes of Kansas, 1949.

BE IT FURTHER RESOLVED that this Resolution be spread on the records of the County Clerk's office of Douglas County, Kansas, as provided
