The Board of County Commissioners of Douglas County met in regular adjourned session with all members of the Board present.

The following resolution on Project #1 - FAS - 210 (1) (Condemnation and appropriation of land for the use of Road purposes, County Highway 290 - one mile north of Baldwin, was passed by the Board:

BEFORE THE BOARD OF COUNTY COMMISSIONERS OF DOUGLAS
COUNTY, KANSAS.

IN RE: The Condemnation and appropriation of certainland taken for the use of the County for Road purposes; namely, the widening, altering, straightening, and relocating a portion of County Highway, 290, one mile north of Baldwin City, Kansas.

RESOLUTION AND ORDER CONDEMNING LAND

WHEREAS, the Board of County Commissioners of Douglas County, Kansas, have met at a regular session on this 27th day of July, 1957, the following commissioners being present: Chairman, Elmer W. Ousdahl, Will H. Hayden, and Walter Kampschroeder.

WHEREAS, the Board of County Commissioners now find it necessary to widen, alter, straighten, and relocate a portion of the County Road known as County Highway 290, beginning a mile North of Baldwin City, Kansas, and continuing in a northerly direction approximately 1.87 miles, and that all efforts necessary to obtain the necessary additional land for widening, altering, straightening, and relocating said portion of road have failed as to certain land, hereinafter described, and it is not possible to obtain said land and additional right-of-way either by donation or purchase, and that it is therefore necessary to acquire the same by condemnation and to exercise the right of eminent domain.

And thereupon, the following resolution was offered by Walter Kampschroeder, Commissioner, and on motion duly made, seconded and unanimously carried, all Commissioners voting "yes" was adopted.

R E S O L U T I O N .

In reference to the condemnation and appropriation of certain land in Douglas County, Kansas, for the purpose of acquiring and procuring certain land for road purposes, namely, to widen, alter, straighten, and relocate a portion of the County Road known as County Highway 290, beginning a mile North of Baldwin City, Kansas, and continuing in a northerly direction 1.87 miles, now THEREFORE, BE IT RESOLVED AND IT IS HEREBY ORDERED:

1. That said road should be widened, straightened, altered, and relocated as shown by the map, plans, profile, and specifications of the County Engineer of Douglas County, Kansas, and filed with the County Clerk of said County and State.

2. That it is hereby determined by said Board that the nature of the changes required and to be made in said County Highway
