The Board of County Commissioners of Douglas County met in regular adjourned session with all members of the Board present.

Commissioners Order #827 was approved for cancellation of personal property, Order on file in the office of the County Clerk.

The following resolution to sell abandoned automobiles was approved by the Commissioners:

RESOLUTION
TO SELL ABANDONED AUTOMOBILES

The Board of County Commissioners of Douglas County, Kansas, met on the 29th day of March, 1958, Present were: Chairman, Will H. Hayden, and members, Elmer W. Ousdahl, and Walter Kampschroeder.

Upon motion of the Chairman, Will H. Hayden, seconded by Elmer W. Ousdahl, the matter of selling the following described abandoned automobiles, to-wit:

One 1947 Ford 4-door, 1953 California License No. 3F3393;
One 1939 Buick 4-door 1952 Kansas license No. DG 10219;
One 1947 Pontiac 4-door, no license number;
One 1939 Chevrolet coupe and one 1935 Dodge 4-door, 1951
California License No. 426094;

comes on for hearing; said automobiles now being located on the County Shop premises of Douglas County, Kansas.

After hearing of testimony produced by the Sheriff, the County Engineer and the County Attorney, with regard to the aforementioned abandoned automobiles, the Board finds:

1. That all of said automobiles have been abandoned for at least three years next preceding this Resolution.
2. That the Kaw Motor Salvage and Glass Co., has toll liens against several of these automobiles.
3. That said automobiles have no sale value other than for junk purposes.
4. That the owners of said automobiles have failed to claim said vehicles within a reasonable period of time after they were found abandoned on said highways of the State of Kansas by the Sheriff's Office of Douglas County, Kansas.

IT IS THEREFORE ORDERED, all members voting in the affirmative:

1. That the sheriff of Douglas County, Kansas, shall ask for bids from at least three junk dealers in Douglas County, Kansas, on the above described vehicles and not requesting bids on said vehicles, the Sheriff shall instruct the junk dealers that said automobiles cannot or shall not be sold at retail, but that said automobiles must be junked.
2. That the Sheriff of Douglas County, Kansas, shall accept the highest bid for said automobiles; and that the money obtained from the sale of said automobiles shall be used as follows:
 1. That the costs of the sale of said automobile must be paid.
 2. To pay the liens against said automobiles owed to the Kaw Motor Salvage and Glass Company, 724 North 2nd, Street, Lawrence, Kansas, the balance of said money shall be deposited with the County Fund of Douglas County, Kansas, in the County School Fund.

IT IS FURTHER ORDERED, that the Sheriff of Douglas County, Kansas, shall keep a record of his proceedings concerning the sale
