RESOLUTION DIRECTING THE FOLLOWING COUNTY  
OFFICIALS OF DOUGLAS COUNTY, KANSAS, TO DEPOSIT  
ALL MONIES RECEIVED BY THEM IN THEIR OFFICIAL  
CAPACITIES IN THE BANKS AS DESIGNATED AS FOLLOWS:

WHEREAS, it is required that the Board of County Commissioners comply with Section 9-302-303, General Statutes of Kansas, 1935, designating depositories for all public monies received by county officials in their official capacities.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Douglas County, Kansas, in regular session this 19th day of January, 1959, that all county officials named herein deposit all public monies received by them in their official capacities in the banks as designated below, and
