WHEREAS, the Board of County Commissioners has heretofore created Riverside Sewer District No. 8, of Douglas County, under and by authority of Section 19-2704A, et sequi General Statutes of Kansas, 1949, and Acts Amendatory or Supplemental thereto and the same provide for the issuance of bonds to pay the cost of improvements, and

WHEREAS, on the 17th day of January, 1958, the contract for the construction of Sewer Improvements in Riverside Sewer District No. 8, Section I and II were awarded for a total of \$94,006.59, said bid being within the engineer's estimate of a \$123,656.00 for construction purposes only, and

WHEREAS, the boundaries of Riverside Sewer District No. 8 and the boundaries of the area served by Section II of the contract aforesaid have heretofore been determined and are hereby ratified and confirmed in all respects, and

WHEREAS, Black & Veatch, consulting engineers on said contracts, Section I and Section II thereof, report the completion of the same and have filed with the County Clerk, their final estimate of costs in the total amount of \$110,486.29, and,

WHEREAS, additional interest on the temporary notes heretofore issued will amount to approximately 1,000, making a total of 111,486.29, and

WHEREAS, the total cost of \$111,486.29 shall be assessed over a twenty (20) year period as provided by law on a per acre basis against the property benefited by the improvements heretofore authorized and completed.

NOW, THEREFORE, THE BOARD OF COUNTY COMMISSIONERS OF DOUGLAS COUNTY, KANSAS, GOVERNING BODY OF RIVERSIDE SEWERIDISTRICT NO. 8, does hereby find and determine that the total cost of the improvement of Riverside Sewer District No. 8 is \$111,486.29; that all of the property benefited by said improvement is benefited equally and said costs be and the same are hereby apportioned and assessed equally on a per acre basis within the above named district pursuant to Section 19-2704A through 19-2715 General Statutes of Kansas 1949 and any and all amendments thereto; that the amounts levied and assessed on all lots and tracts of land within said Riverside Sewer District are respectively in the amounts set opposite several tracts of land in the table of assessments set out below, to wit:

SCHEDULE OF ASSESSMENTS - RIVERSIDE SEWER DISTRICT NO. 8 FOR SECTION I AND SECTION II OF SAID CONSTRUCTION CONTRACT. (This schedule is on file in the County Clerk's Office)

IT IS FURTHER FOUND, DETERMINED, RESOLVED AND ORDERED, that Riverside Sewer District No. 8 through its Governing Body, the Board of County Commissioners shall hold a special session to hear any complaints that may be made as to the apportionment of costs and that such hearing shall be had at 10 o'clock A.M. August 10, 1959, at the office of the Board of County Commissioners, Douglas County, Kansas, Courthouse, Lawrence, Kansas, and that this Resolution be published for two consecutive weeks in the Lawrence Daily Journal World, the official County paper of this County.

It is further RESOLVED and ORDERED, that the County Clerk of Douglas County, Kansas, shall mail a written or printed notice to the owner or owners of each of the tracts of land in Riverside Sewer District No. 8 liable for such Special Assessment, whose names and post office addresses can be ascertained from the County Records, which notice shall set forth time for hearing complaints, the amount assessed against each tract of land within the said Riverside Sewer District No. 8 and if any such assessments on said tracts of land are not paid in full within thirty (30) days from August 10, 1959, bonds of said County will be issued in the amount therefore, and such unpaid assessments will be spread upon the tax rolls in twenty (20) equal annual installments to include interest on deferred payments at the rate per annum not exceeding that authorized by Section 10 G.S.Kansas, 1949, and all acts amendatory thereto.

It is further RESOLVED and ORDERED, that this Resolution be published in the Lawrence Daily Journal World, the official County paper of Douglas County, Kansas, and that the notices refered to here and above shall be mailed by the County Clerk to such property owners at least two weeks prior to the time for hearing of complaints, if any.
