The Commissioners agreed to purchase a desk, filing cabinet and 4 chairs for the County Superintendent's office at a cost of \$280 complete.

The Commissioners passed the following Resolution to vacate and relocate roads Numbers 20-220-401-464 as provided in Section 68-102:

## R E S O L U T I O N

WHEREAS, The Board of County Commissioners of Douglas County, Kansas, unanimously find that it would be to the best interests of Douglas County, Kansas, to vacate and relocate Roads Numbers 20-220-401-464, as provided in Section 68-102 of the Revised Statutes of Kansas, 1945.  
As described,

## VACATE

Beginning at a point in Road Number 220 at a point 1153 feet South and 254 feet West of the Northeast corner of Section 1, Township 14 South, Range 18 East, thence along center lines of roads numbers 220-401-20 - through Sections 1 and 2 in Township 14 South Range 18 East, thence along center line of Road 464 through Section 11 and terminating at a point on the South line of the Northeast Quarter of Section 11, Township 14 South, Range 18 East, 455.6 feet East of the Center Quarter Corner.

## RELOCATE

Beginning at a point in Road number 220 at a point 1153 feet South and 254 feet West of the Northeast corner of Section 1 Township 14 South, Range 18 East, thence South 75 degrees 36' West 2,611.85 feet to the P.I. of a 7 degree curve to the left, thence South 45 Degrees 54' West 1135.1 feet to the P.I. of a 4 degree curve thence South 61 Degrees 50' West 782.15 feet to the P.I. of a 4 degree curve, thence South 43 Degrees 57' West 947.85 feet to the P.I. of a 4 degree curve, thence South 35 Degrees 22' West 1,003.65 feet to the P.I. of a 7 degree curve, thence South 54 Degrees 45' West to the P.I. of a 11 degree curve, thence South 4 degree 45' West 1179.7 feet to the P.I. of a 4 degree curve, thence South 18 degree West 1,586.8 feet, terminating at a point in the South line of Section 11, Township 14 South, Range 18 East 455.6 feet East of the Center Quarter Corner of said Section 11. Width of 70 feet with Easement of variable widths.
