R E S O L U T I O N

WHEREAS, the Board of County Commissioners of Douglas County, Kansas, have met at a regular session on this 30th day of December 1959. The following commissioners being present: Chairman, Walter K. Kampschroeder, Commissioner, Elmer W. Ousdahl and Commissioner, Will H Hayden.

WHEREAS, it has been shown to the commission that on or about the 5th day of October, 1957, one, Sharon Lee Stewart, was brought before the County Court, charged with drunk on a public highway and was fined \$50.00 and \$5.00 court costs. That the said Sharon Lee Stewart, was unable to pay the fine and costs and was remanded to the County Jail; that shortly thereafter she received a wire from St. Joseph, Missouri, stating that her mother was seriously ill and that said subject was released by the County Judge; that the stated fine and costs although not paid were erroneously listed in the books of the County Court under receipt number 8378; that subsequent correspondence by the County Attorney and investigation by the County Court show that said amount was not in fact paid nor has it been paid to this date.

NOW, THEREFORE, BE IT RESOLVED BY The Board of County Commissioners of Douglas County, Kansas, on this 30th day of December, 1959, that the books of the County Court be corrected to show that the \$55.00 has not been paid and that said action be so reflected in the audit of said books.
