The Board of County Commissioners of Douglas County met in regular adjourned session with all members of the Board present.

Road and bridge matters were discussed with the County Engineer, Casey Rice.

Bids were received and opened on patrol car for sheriff. Low bid was accepted in the amount of \$1115. Low bidder was Broers Chevrolet of Eudora. (Bids on file in the office of the County Clerk.)

A motion was made by Commissioner Ousdahl, seconded by Commissioner Hayden, and passed unanimously, that the Chairman of the Board of Douglas County Commissioners, be instructed to sign the following contracts (see contracts in the office of the County Clerk) pertaining to the construction of the Douglas County Home for the Aged, with the Constant Construction Company of Lawrence, Kansas, as general contractor; with Carey Plumbing and Heating Company of Ottawa, Kansas, for the plumbing and heating; and with Norris Brothers of Lawrence, for the Electric wiring. Said contracts were signed by the Chairman of the Board of County Commissioners in accordance with the above motion.
