Resolution follows: RESOLUTION WHEREAS, the Board of County Commissioners of Douglas County, Kansas, have met at a regular session on the 8th day of June, 1960, the following com-missioners being present: Walter Kampschroeder, Chairman, Will H. Hayden, Member and Elmer Ousdahl, Member. WHEREAS, the Board of County Commissioners have received and considered the Petition and Bond for the location of the following described road; the center line of which is described as follows: Beginning of the point 455.8 feet North and Thirty-three (33) feet West of the Southeast corner of Section six(6), Township Thirteen (13) South, Range Twenty (20) East, in Douglas County, Kansas, thence West 619 feet. said road to be fifty (50) feet wide with a temporary turn around at the West end and a radius of Forty (40) feet until the said road is extended West. and the second s Whereas, the Board of County Commissioners find the petition to be a legal one and that the proper Bond has been filed, and the said Board further find that the Lawrence Industrial Development Company, Inc., owner of the above land has dedicated the above land for public road use.
