No definite action was taken but it was the opinion of both the Commissioners and the representatives of the other agencies that we attempt to work out a compromise if Mr. Demeritt could see his way to raise his appraisal to some extent.

The Board adjourned.

The Board of County Commissioners of Douglas County met in regular adjourned sesson with all members of the Board present.

Road and bridge matters were discussed with the County Engineer, Casey Rice.

Motion was made by Mr. Hayden, seconded by Mr. Ousdahl, and passed unani-mously that Resolution pertaining to location of roads in Section 14, Township 13, Range 19, Wakarusa Township, be adopted:

RESOLUTION

WHEREAS, the Board of County Commissioners of Douglas County, Kansas, have met at a regular session on the 18th day of July, 1960 the following Commissioners being present: Walter Kampschroeder, Chairman, Will H. Hayden, Member and Elmer Ousdahl, Member.

WHEREAS, the Board of County Commissioners have received and considered the Petition and Bond for the location of the following described roads:

Beginning at a point 562 feet West and 33 feet South of the Northeast corner of the Northeast Quarter of Section 14, Township 13 South, Range 19 East, Douglas County, Kansas; thence South parallel with the East line of said Quarter Section 279 feet; thence Southwest 310.45 feet to a point 592 feet West and 621 feet South of the Northeast corner of said Northeast Quarter; thence South parallel with said East line 684.4 feet, the said road to be 60 feet in width. road to be 60 feet in width.

ALSO - Beginning 622 feet West and 640 feet South of the Northeast corner of northeast Quarter of said Section 14, thence West 703.3 feet, the said road to be 60 feet in width with a temporary turn around at the West end and having a radius of 40 feet until the said road is extended West.

ALSO - Beginning at a point 1092 feet West and 651 feet South of the Northeast corner of the Northeast Quarter of said Section 14, thence South 671 feet, the said road to be 60 feet in widt.

ALSO - Beginning at a point 1325.5 feet South and 40 feet West of the Northeast corner of the Northeast Quarter of said Section 14, thence West 1287 feet, the road to be 30 feet in width all North of the above line.

WHEREAS, The Board of County Commissioners find the Petition to be a legal one and the proper bond has been filed, and the said Board further find that Walter Nieder, Gladys Nieder, Albert L. Campbell, Betty Campbell, Harry Dauberman and Eleanore dDauberman, owners of the above described land have dedicated the above land for public road use.

WHEREAS, the Board find that the location of said roads prayed for is practi-cable and can be made without unreasonable expense and that it is not nec-essary to view such location of said roads. It is therefore ordered that the said roads shall be surveyed, platted, and opened and that the County Engineer shall note such locations upon the road records of his office.

It is FURTHER ORDERED that a copy of this resolution be given to the Trustee of Wakarusa Township and the same will be his authority to open said roads for public travel.

It is THEREFORE BY THE BOARD OF COUNTY COMMISSIONERS OF DOUGLAS COUNTY, KANSAS, SO RESOLVED AND ORDERED this 18th day of July, 1960
