2. That it is hereby determined by said Board that the nature of the changes required and to be made in said County Highway No. 589, shall comply with and conform to the said map, profile, plans, and specifications prepared therefor by the County Engineer of Douglas County, Kansas.

3. It is hereby determined by said Board that the approximate amount and location of land to be taken for said purpose, is all situated in Douglas County, Kansas, and described as follows:

Tract 1. - owner, Walter J. Stoebener. Beginning at a point on the East line of the Southwest Quarter of Section 1, Township 15 South, Range 18 East of the 6th principal meridian in Douglas County, Kansas 63 feet North of the Southeast corner of said Quarter Section; thence North on Quarter section line 2577.15 feet to the Northeast Corner of said Quarter section; thence West on North line of said Southwest Quarter 115 feet; thence South parallel to East line of said Quarter section 2577.15 feet; thence East 115 feet to the point of beginning, containing 6.804 Acres more or less.

Tract II - Owner, Walter J. Stoebener. 5. That at said viewing, the said Board of County Commissioners shall assess damages by reason of the taking thereof, and if said work shall not be com-pleted on said, day, they will adjourn from day to day without further notice, until their labors are fully completed.

6. That the County Engineer is hereby directed to meet with the said Board of County Commissioners at said time and place for such view.

7. That notice of the time and place of such viewing shall be published and served on said owners as provided by law, and all persons claiming or to claim damages by reason of the proceedings and actions of the Board of County Commissioners in reference to said view and the changes to be made in said County Road shall file their applications, therefor in writing, with the County Clerk of Douglas County, Kansas, on or before the first day of the next regular session of the Board of County Commissioners, wh ich said Board meets on Mondays, Wednesdays and Saturdays of each week at 9:00 A.M. following the filing of and report of the findings of such view, and at such regular session of the Board, the Board will finally determine upon the amount to be paid as damages to the owners of the above described property.
