

## COMMISSIONER'S RECORD P

## A G R E E M E N T

This agreement made at Lawrence, Kansas, this 26th day of July, 1961, by and between The Board of Education of the City of Lawrence of the State of Kansas, herein described as first party and The Board of County Commissioners of the County of Douglas, herein described as second party.

## WITNESSETH THAT:

WHEREAS, the parties hereto desire to provide special education services for the schools of Douglas County, in the field of psychological testing and services and in the field of speech correction,

NOW THEREFORE, it is mutually agreed:

1. The first party will provide the following personnel:

Director of special education, one-eighth time;

One school psychologist, three-eighths time;

One instructor-correctionist in speech correction, full time.

2. Such personnel shall provide the schools of Douglas County county, within the time allotted as above set out, services for screening tests, special testing, referrals and therapy.

3. Such services shall be provided during the school year 1961-62 at such times and places as mutually agreed upon in judgment by the party of the first part and the Douglas County Superintendent, which shall be beneficial to the children involved, having regard to efficiency of operation, and other duties of said personnel.

4. Second party shall pay first party, for such services, the sum of \$1200.00 as follows:

The sum of \$1200.00 on December 1, 1961, and a like sum on each month there following, until said sum of \$-----is fully paid.
