referred to as the Political Subdivision submits the following plan to the Kansas Department of Administration, as the authorized State Agency, for approval as authorized by Article 23 of Chapter 40 of G. S. 1959 Supplement, as amended.

- (A) The Political Subdivision agrees that the provisions of Article 23 of Chapter 40 of G. S. 1959 Supplement, as amended, hereinafter referred to as the State Act shall be and are agreed to as a part of this plan.
- (B) Services covered.

This plan includes coverage of all services performed by employees of the Political Subdivision except as specifically ex-cluded by law and (including) (excepting) elected officials of the subdivision, if any.

- (C) Contribution by the Political Subdivision.
 - (1) The Political Subdivision hereby agrees to pay to the Department of Administration, at such time or times, and in such manner, as the department may by regulation prescribe amounts equivalent to the sum of the taxes which would be imposed by Section 1400 and 1410 of the Internal Revenue Code if the services of the employees covered by this agreement constituted employment as defined in Section 1428 of such code.
 - (2) The Political Subdivision further agrees to deduct from any remuneration paid to an employee subject to the provisions of this plan an amount equivalent to the sum of the taxes which would be imposed by Section 1400 of the Internal Revenue Code if the services of said employee constituted employment as defined in Section 1426 of such code.
 - (3) Sources of Political Subdivision's Contributions.

Solices of rotacal subdivision's Contributions. The Political Subdivision will pay its contributions from the same fund or funds that the wages from which the con-tribution in (2) above is made are paid or from any other funds available to it for the purpose and/or that it will anually or when necessary levy at the time of its levy for other purposes, a tax which may be in addition to all other taxes authorized or limited by law, for the purpose of making its contributions under Subsection (c) of Section 40-2305 of the General Statutes Supplement of 1959, as amended, which tax together with any other funds available to the Political Subdivision for such purpose shall be sufficient to enable it to make its contributions: *Provided*. The Po-litical Subdivision verily believes that with the current funds that may be available and the unlimited tax kevy authorized by Subsection (c) of Section 40-2305 of the General Statutes Supplement of 1959, as amended, reasonable current statutes supplement of 1959, as amended, which tax together and the unlimited tax kevy authorized by Subsection (c) of Section 40-2305 of the General Statutes Supplement of 1959, as amended, which the current funds that may be available and the unlimited tax kevy authorized by Subsection (c) of Section 40-2305 of the General Statutes Supplement of 1959, as amended.

(D) Compliance with regulations.

The Political Subdivision further agrees that it will comply with such rules and regulations as the Department of Admin-istration may prescribe to carry out the purposes of Section 218 of the Social Security Act as amended.

(E) Modification.

This plan may be modified at the request of the Political Subdivision to include additional groups, or additional services not now included, such modification to be consistent with the provisions of Section 218 of the Social Security Act, as amended, and the State Act.

(F) Termination by the Political Subdivision.

The Political Subdivision, upon giving at least two years' advance notice in writing to the Department of Administration, may terminate this plan, either in its entirety or with respect to any coverage group, effective at the end of a calendar quarter specified in the notice, provided, however, that the plan may be terminated in its entirety only if it has been in effect not least than five years prior to receipt of such notice, and provided further that it may be terminated with re-spect to any coverage group only if it has been in effect with respect to such coverage group for not less than five years prior to receipt of such notice.

(G) Termination by the Department of Administration for cause.

If the Department of Administration, after reasonable notice and opportunity for hearing to the Political Subdivision, finds that the Political Subdivision has failed or is no longer legally able to comply substantially with any provision of this plan or of Section 218 of the Social Security Act, as amended, the Department of Administration shall notify the Political Subdivision by giving notice in writing that this plan will be terminated in its entirety, or with respect to any one or more coverage groups, at such time, not later than two years from the date of such notice, as the Department of Administ-tration decrems appropriate, unless prior to such time it is found there so longer is any failure or that the cause of such legal mability has been removed.

(H) Failure to make payments when due.

Pursuant to the provisions of Subacction (d) of Section 40-2305 of the General Statutes Supplement of 1959, that in the event Political Subdivision fails to make, at the time or times due, the payments provided for under this plan, there shall be added, as part of the amounts due, interest at the rate of six (6) per centum per annum from the date due until paid, end the Department of Administration may deduct such amount as is delinquent, plus accrued interest, from any amounts due the Political Subdivision from any department or agency of the State of Kansas. Amounts so deducted shall be deemed to have been paid to the Political Subdivision.
