The Board adopted the following Resolution creating a Civil Defense Organization and Director:

R E S O L U T I O N

WHEREAS, the Board of County Commissioners of Douglas County, Kansas, have met at a regular session on this 13th day of January, 1962, the following Commissioners being present: Elmer Ousdahl, Chairman, Walter Kampschroeder, Member, and Harvey Booth, Member.

And, WHEREAS, Kansas G.S. 1959 Suppl., 48-903 has authorized the creation of local organizations for civil defense in the political subdivision of the State of Kansas.

BE IT NOW THEREFORE RESOLVED BY the Board of County Commissioners of Douglas County, Kansas, that there is hereby created the office of the Douglas County Civil Defense Director. That said Director shall be appointed by the Board of County Commissioners and that Howard Lindley of Lawrence, Kansas, is a fit and qualified person for said position and is hereby appointed as said Douglas County Civil Defense Director. That the function of said Douglas County Civil Defense Director shall be to prepare a Douglas County Civil Defense plan with the cooperation of County Officials and during periods of emergency to obtain vital supplies and equipment needed for the protection of life and property of people and to bind the county for the value thereof and if required immediately to requisition the same.

BE IT NOW THEREFORE FURTHER RESOLVED that a Civil Defense Organization be and it is hereby created for the purpose of aiding County Officials and employees as requested in the event of emergency that the training and coordination of efforts of said organization, which is a volunteer organization serving without pay, shall be vested in and under control of the Douglas County Sheriff, Lawrence Chief of Police, Chief of the Campus Police and Douglas County Civil Defense Director.
